Erin Creemore Service Planning Supervisor and Joe Weatherby Operations Supervisor began pointing out the extra measures that APS will be taking this year.

In the event of a fire, they work with the emergency responders to make sure they are doing safety shut-offs so that they can work around facilities safely. PAGE 2

MAY 26, 2022 COUNCIL ACTION

They perform integrated vegetation management by conducting annual inspections of transmission and distribution lines and, in accordance with all state regulations, clear overgrowth to ensure safe clearances around our equipment within those rights-of-way. They noted the outages could be longer during the summer because they do not have the automated systems that kick in, but they are sending a multi-trouble man to make sure they can get through the lines quickly.

Joe shares the same concerns as the Mayor regarding an elevated fire hazard this year. He spoke too about the prolonged power outages until crews can perform visual inspections of lines and remove any vegetation or potential hazards from around their equipment that could pose fire risks. In the event of a wildfire, power lines may be temporarily taken out of service to protect firefighters, which could result in outages that might last longer than usual.

They spoke about having installed branch fuses to reduce the number of homes to be without power at a given time. And, about their communication with customers; they are mailing postcards to customers in high fire risk areas emailing and bill messages, radio and newspaper ads, and providing Online Outage Center and Wildfire Safety pages for the communities.

As you may be aware of by now, Drake Cement LLC has staked and filed claims for yet another Pozzolan mine. These mining claims are south of town, on the east side of Bill Williams Mountain, within the city limits. The claims are staked over critical watershed areas, archeological sites, APS powerlines, the Benham hiking trail, and abuts private property on multiple sides. The access will be the Perkinsville Road. This letter represents the feelings, hopes, and determination of citizens and/or property owners along Perkinsville Road, and other parts of Williams. Our hope is that you will oppose the mine and make your feelings known, as there are many immediate and long-term negative impacts this can have on the City of Williams and surrounding areas.

- 1. The geology of the area in and around Bill Williams Mountain is predominately Pozzolan in nature. Even areas in downtown Williams have prominent Pozzolan outcrops. Drake Cement LLC, has already opened a nearby mine at Frenchy Pit. The Kirkland Pozzolan mine was also recently opened in Skull Valley (to the detriment of the locals who are seeing their property values, air quality, and quiet destroyed). The regional cumulative effects of these mines and possibly future mines are very concerning for the area. Because of the proximity to the town and residents, private property, and the access of the mine through residential areas and the middle of town, we have to ask, "why here"? Perhaps working to encourage exploration and utilization of other sites may be appropriate.
- 2. Williams is a lovely, quaint community surrounded by our beautiful Kaibab National Forest. Williams depends on tourism and outdoor enthusiasts. A mine scar on the side of Bill Williams Mountain will degrade the view scape for generations to come. Pollution and noise from the operating mine, as well as large trucks going through the center of town will not be appealing to tourist and residents alike. Not to mention the effect it will have on the wildlife.
- 3. Several sensitive watersheds and clean water, like Cataract Creek, immediately abuts and runs through these mine claims. With recent climate issues and drought in the area, we must protect this natural resource so important to the town of Williams and its future.
- 4. Industrial scale operations increase the risk of wildland fire, especially given the climate trends of late and the extended drier fire regimes that are now prevalent. We have all seen how catastrophic fires have been started by a single spark. The Forest Service and cooperative entities have spent millions of dollars attempting to mitigate fire danger and its effects by thinning the forests. These investments and efforts are at a higher catastrophic fire risk by an operating mine.
- 5. Other than Drake Cement having a local inexpensive source of Pozzolan to enhance its profits, there is no other value to this mining endeavor. The people of Williams have invested in the area mostly because of the clean rural lifestyle. Their property values will be affected as well as the lifestyle they have enjoyed. The tourists love the area because of the quaint small-town atmosphere, and the opportunities to enjoy beautiful outdoor spaces that surround it. Drake Cement does not live here or care deeply about this city, its people, or the city's image as a rural scenic western tourism town.

We ask that you support our efforts in opposing this potential mine. Time is of the essence. We must make our feelings and desires known before Drake Cement submits its Notice of Intention to Operate and a Plan of Operation to the Forest Service. During this period the Forest Service has latitude to oppose this mine. Therefore, it's very important to establish and maintain positive communication with the Forest Service now. Please talk to the Forest Service (both Forest Supervisor Nicole Branton and Williams District Ranger Debra Mollet) and ask them to oppose this mine. And please present this information before the forthcoming Williams City Council and when appropriate, Williams Planning and Zoning and enter this letter and your decision into the public record. A reply with your actions and decision would be most appreciated. Thank you.

Pozzolan mining on Bill Williams Mountain not a good fit for community

his letter is provided to share some specifics regarding Bill Williams Mountain, the Cataract Creek Wash watershed, and an open pit pozzolan mine that Drake Material and Cement Company is planning to open within this watershed

My goal is to point out reasons why this mine should not be approved.

Bill Williams Mountain was identified by both the city of Williams and the U.S. Forest Service as a critical resource deserving special protection from catastrophic wildfire in the Greater Williams Area Community Wildfire Protection Plan (2005).

It is an important sacred site and traditional use area to several south-western tribes and has been determined eligible as a traditional cultural property. The Cataract Creek Wash watershed, a small ski resort, Benham Trail #38, private property and homes are all located on the east side at the base of the mountain.

The Cataract Creek watershed lies within Drake's mining claim boundary. The city of Williams relies heavily on this watershed to provide clean and abundant water to the city of Williams reservoirs for their domestic drinking water.

Not all risk from mining to the watershed can be mitigated despite Drake's standard risk mitigation language included in all their operating plans. Any damage could potentially prove catastrophic.

Any large naturally occurring or mining operation caused wildfire on the mountain would likely result in flooding, which could run through or from the mine and into Cataract Creek. This disaster would result in long lasting impacts that include erosion, sedimentation, silting of Santa Fe Reservoir and altered landscapes. Consider how often the Forest Service completely closes this watershed due to fire danger and you start to understand the risk.

Protecting this watershed is the primary reason the Forest Service should not support this claim, and the only way to not accept unnecessary risk to this critical resource. It would be the right choice for Drake to select a different low impact location to open a common pozzolan (volcanic ash) mine.

The Forest Service should be thinking prevention versus mitigation. Mitigation means to reduce the severity of the human and material damage caused by the disaster. Prevention is to ensure that human action or natural phenomena do not result in disaster or emergency.

If this claim does go forward, Drake and the Forest Service should expect strong opposition from Williams residents who will undoubtedly choose the safety of their drinking water supply over Drake mining profits. Once residents are alerted, I am sure they will make their concerns known to their elected officials and the Forest Service. If the Forest Service decides to support Drake, I would not be surprised to see this mining claim wind up in the courts.

The bottom line is a mine in this location could potentially prove catastrophic to the watershed. A mine located in this location would also result in a significant increase in heavy truck traffic through the center of Williams. It would degrade camping and hiking, and negatively impact tourism and hunting. It further degrades Mexican Spotted Owl habitat.

It would also require dust control due to pozzolan containing crystalline silica, which upon long-term exposure may produce bronchitis, silicosis, a fibrotic (scarring) disease of the lungs and potentially lung cancer. It would decrease private property values.

For all these reasons, I hope you would agree that a mine in this location should not be allowed, and take the action to prevent this mining operation from being approved.








