II. PRESENTATIONS – Jeff Worner of KR Saline presented information regarding the power cost adjuster and another opportunity to buy into another solar project.

Jeff covered many things about the Williams 2023 Energy Supply and spoke of Brightnight (BOCA) Solar and the AEPCO Solar Project.

- He went over natural gas prices and forward prices.
- Power Cos Adjustor and calculations.
- Update as of July 2023 on the Power Cost Adjustor and how by May 2024, it is estimated to reach zero.
- He spoke of estimated annual bill impacts and an APS billing comparison.

JULY 27, 2023 COUNCIL ACTION

- Staff PCA recommendation is to 1. Maintain current PCA @ \$0.0423/kw. Revisit PA in late sprint 2024 when the PCA balancing account is estimated to reach zero. 2. Continue to monitor actual power costs and PCA collections for future necessary adjustments (up or down).
- He spoke of the city being approached, through the Southwest Public Power Agency (SPPA), to jointly participate in a new solar and battery project being developed by AEPCO, which is expected to come online in the summer of 2025. He mentioned favorable pricing when federal grants are applied.
- He went over our current monthly capacity load and resources without AEPO Solar and Battery and our needs showing how we are short on capacity.
- He showed the capacity and energy load resources with AEPCO Solar.
- With a deadline of July 14, 2023, for expression of interest, the city requested its proportionate share at (5MW) of the AEPCO Solar project and 5MW of the battery project.

- Robin Eckels-Smith requests the city to consider the property for SAVE Meant to Rescue to be considered vested.
- Andrea Dunn tanked the PD for the speed monitor and noted that the stop sign had helped.
