CONTINUATION – PUBLIC HEARING – GENERAL PLAN

The Planning and Zoning Commission and City Staff will be presenting maps and information about the Current 2013 General Plan and will solicit information and recommendations from the public pertaining to the planning elements of the General Plan. We will be conducting at least 4 to 5 meetings this year before we finalize the 2023 General Plan.

Tim addressed Commissioners regarding the updated General Plan. This is the final Public Hearing for any inputs from the Community, we will continue to update with any other comments or suggestions from the Commissioners.

Steven Dudley asked if his inputs from the mining section were incorporated into the General Plan. Tim explained that it was addressed, but was using very General wording, we are attempting to be more accurate in the proper wording of the General Plan, since this document will be used for the next 10 years.

Tim also informed the Commissioner's that a housing study has been prepared and he hopes to have this document available for the Commissioners review. The survey was very professional done and did show areas of concern for Williams.
